MEMBERS ALSO AGREE NOT TO CROSSBREED WITH ANY OTHER BREED OF DOG EXCEPT ANY NZKC REGISTERED BULL TERRIER (MINIATURE) AS OUTLINED BY THE NZKC PROTOCOLS. NOR WILL THEY BREED OR OFFER TO BREED TO ANY UNREGISTERED BULL TERRIERS.

MEMBERS DECLARE NOT TO BREED FROM OR EXHIBIT DEAF BULL TERRIERS. THE EXHIBITION OF DEAF BULL TERRIERS IS RESTRICTED TO RIBBON PARADE LEVEL ONLY AND THEY ARE NOT ELIGIBLE TO ENTER ANY OPEN OR CHAMPIONSHIP SHOWS HELD UNDER NZKC RULES
