Or of a DogsNZ All Breeds or Specialist (Multi, Group or Breed) Club

** An observational test is required as part of bronze testing. If the vet cannot confirm then the owner or breeder can request a review by their club. DNA or confirmation of clearance by parentage will be required either at review or for all dogs applying at silver level. Failure of the review or DNA test will cause the bronze level award to be revoked and the \$10 fee will be returned.

Administrative Fee

A fee of \$10 is payable to meet the administration and certificate costs. If you are sending in two or more registrations then pay only one \$10 fee. The fee can be paid to ANZ 01-0505-0912451-00. Please include your surname and DNZ number in the reference details.
