Upon completion of this form the current NZ ROM Committee will complete a review of the information provided and a copy is to be forwarded to the NZ Member Clubs for input. The NZ Member Club's committee will have a period of no more than 28 days in which to lodge any formal objection and provide a rationale.

Where no objection is received from the NZROM Member Clubs within 28 days, the Judges details will be included on the NEW ZEALAND ROM JUDGES LIST conditional on completing the first Dogs NZ affiliated Bull Terrier Club judging appointment. Where any objection is received a vote will be undertaken by the NZROM Member Clubs to confirm the status of the submission.

This form serves to provide information in which the judge can demonstrate how they meet the New Zealand criteria to be a ROM Judge and where the answer to any question is NO, this may suggest that the relevant criteria has not been met.

In accordance with NZ ROM Rules the following criteria is utilised to assess the eligibility of a Dogs NZ Judge

1. Bred or owned Bull Terriers for not less than ten years
2. Must have bred and raised a minimum of five litters of Bull Terriers. Litters and co-owned litters must have been whelped and raised on the applicants premises.
3. The first ROM judging appointment MUST be for a Dogs NZ affiliated - Bull Terrier Club show.
4. Must be a Dogs NZ licensed judge.
5. Must be able to document having accomplished any combination of three of the following components.
 - a. Bred at least two ROM titled dog/s
 - b. Have personally exhibited two Bull Terriers to their ROM
 - c. Bred at least two BIS or RIS specialty winners.
 - d. Have bred a minimum of two Bull Terrier Champions.
 - e. Have personally exhibited two Bull Terriers to their Championships.
 - f. Have 15 years of documented experience exhibiting Bull Terriers in conformation

Any Dogs NZ Judges who feel that they meet the criteria is invited to complete the relevant section of the form, and return the completed document with any relevant, supporting documentation to the NZ ROM Secretary for processing.
